

The *Illuminati* Fact or Fiction?

With all the hype regarding global conspiracies of every kind, I somewhat hesitate to delve into this subject for fear that the information I seek to convey will automatically and unthinkingly be lumped together with every kind of off-the-wall notion that permeates the fabric of modern society.

Still, I strongly believe that there are very intriguing and important facts which true believers ought to at least be aware of, even if they do not wish to study deeply into world history, governmental control, and the plan that Satan is following to bring this world to the

brink of utter destruction. I happen to feel that these things are quite significant, but I also realize that some of what I hope to share with you may not appeal to everyone who hears it. All I can ask is that you give the material serious consideration and come to your own conclusions.

The subject matter we are about to cover is extraordinary, and will, for some, be hard to accept. Therefore, if anything, I am going to understate the facts involved in hopes that everyone will be able to grasp both the premise and the details contained in this message.

For some of you who will hear this tape, the information will not be new. Hopefully, however, this can serve as a reminder or refresher for those who are already aware of what I am about to say.

Although the following material will at times seem incredible, we really should not and indeed cannot afford to be surprised by any possible ploy or tactic utilized by Satan the devil in his wicked desire to bring the children of God to destruction. Those who adamantly refuse to accept the idea that there could be a conspiracy afoot on a global scale are

knowingly or unwittingly ignorant of not only how the mind of the enemy works, but also of the very Word of God itself.

The book of Revelation clearly describes an end-time political/financial/military/religious system known as Babylon. She will become the greatest power the world has ever witnessed. All the earth will be awe of her. She will be the strongest, richest, and most influential power ever. We all know this to be precisely what God's Word tells us. The obvious question, therefore, is just how do we figure that such a situation will possible develop on the world scene without a conspiracy—and a conspiracy at the highest echelons of power at that?

Both the Scriptures, secular history, and pure common sense ought to tell us that there has been, still is, and will continue to be, a Satanic conspiracy among the power elite of this world. The facts of this case are utterly indisputable. There is, in fact, such a volume of valid evidence that you could easily win a verdict in a court of law!

The bottom line in such a conspiracy is power—power to rule over people, power to control all natural resources, power to make money, power to keep money, power to destroy, if necessary, anyone or anything that stands in the way. World domination is the clear objective of the power elite of this earth. It has been the dream of certain men since the garden of Eden.

At the center of all such evil conspiracy is the one great power

necessary to achieve such a lofty goal as complete world rule, and that is Satan the devil. Make no mistake about it, he is the originator of such a plan, and the one who is determined to carry it out. He has tried again and again to manipulate certain people through the eons of human history into key situations and positions where this diabolical objective could be accomplished. God Himself has had to directly intervene in the affairs of man to stop the onslaught and eventual success of this endeavor.

Probably the most renowned of all such divine interventions was the great Flood during the time of the patriarch Noah. The Scriptures state:

“And God saw that the wickedness of man was great in the earth, and that every imagination of the thoughts of his heart was only evil continually...And the Lord said, I will destroy man whom I have created from the face of the earth” (Gen. 6:5-7).

The evil of the pre-Flood world had derived from the original confrontation between Satan and Eve in the garden of Eden. It then spread, particularly through the genealogy of Cain. We read in Genesis 4 that after Cain slew his brother Abel, that God placed a mark on distinction and apparent protection upon him. The Hebrew word for *mark* in this instance is *avth*, and in the ancient Hebrew word-pictures means *blood of the cross*. The following passage in the book of Isaiah contains the identical word and meaning. In Isaiah 46:6, we read:

“Thus says the Lord (YHWH) the King of Israel, and his redeemer the Lord (YHWH) of hosts; I AM THE FIRST, AND I AM THE LAST, and beside Me there is no God.”

The phrase *first and last*, which, as we know, is directly applicable to the Messiah is expressed in Hebrew by the letters *avt*, that is from the *aleph* to the *tov*. This connection between the mark placed by God upon Cain and the clear references to Christ and His blood is rather revealing and indeed quite remarkable.

Once this event had transpired, we are told that Cain was driven from the presence of God east of Eden into the land of Nod. Once there, Cain had a son, and, interestingly enough, the first endeavor he undertook was to build a city in honor of his progeny. This was the first city every built by human beings.

The first-century writers, Flavius Josephus and Philo Judeaus, describe how Cain was the first to gather people together into city-states, always under his control. He was the first to organize standing armies, and his offspring were the originators of metallurgy, the art or science of separating metals from their ores and preparing them for use by smelting or refining. They also were highly successful in metalwork as well, especially the design and making of weaponry.

The Scriptural record connects the gross evil of the pre-Flood world with fallen angelic beings. We read in I Peter 3, beginning with verse 18:

“For Christ also has once suffered for sins, the just for the unjust, that He might bring us to God, being put to death in the flesh, but quickened by the Spirit; by which (the Spirit, that is) He also went and preached unto the spirits in prison; which sometime were disobedient, when once the longsuffering of God waited in the days of Noah, while the ark was being prepared, wherein few, that is, eight souls were saved by water” (I Pet. 3:18-20).

There has long been speculation that the so-called *sons of God* mentioned in Genesis 6:2 were in fact fallen angels. Granted, there are many who repudiate such a position, and I can certainly understand their reasoning. Although this is really outside the scope of this message, I will take time to simply read over the passage. Beginning in verse 1:

“And it came to pass, when MEN began to multiply on the face of the earth, and daughters were born to them, that the SONS OF GOD saw the daughters of MEN that they were fair; and they took them wives of all which they chose” (Gen. 6:1-2).

If this passage is read carefully, it would seem that an emphatic distinction is made between *men* in verse one, and the *sons of God* in verse 2. If one holds to the interpretation that the phrase *sons of God* is a reference only to the line of Seth (a theory employed by many), then there are certain problems that arise. Granted, we all know that the Scriptures give evidence that both man and angels are, at one time or another, called

sons of God. So this information in and of itself is an insufficient basis from which to draw conclusions.

Connecting the Genesis 6 passage with that of I Peter 3, however, does establish a relationship that probably ought to be more fully explored.

Even the Scriptural record goes on to say in Genesis 6:4:

“There were GIANTS (Nephalim) in the earth in those days; and also after that, when the sons of God came in unto the daughters of men, and they bare children to them, the same became mighty men which were of old, men of renown. And God saw that the wickedness of man was great in the earth, and that every imagination of the thoughts of his heart was only evil continually” (Gen. 6:4-5).

The Bible makes a definitive connection between these *sons of God* taking to themselves wives of the daughters of *men*, and the result of such unions producing giants upon the earth. The Hebrew term is *Nephalim*. I really do not have time on this tape to get into detailed possibilities that this subject entails. If anyone is interested in pursuing this topic further, request the tape entitled *Satan’s Insidious Plot*.

Whatever the correct interpretation of Genesis 6:1-2 really is, it goes without challenge that the pre-Flood world was filled with virtually unimaginable evil, and that fallen angels were directly involved with such evil. When one considers the fact that Satan has

long had one great desire—and that is to become God and rule over all things, it is not surprising at all to learn that his plan and plot among human beings as potential children of God are to bring them into subjection. How is this being accomplished? By many means, no doubt, but certainly the ultimate of those avenues leads directly to world domination on a political/social/educational/financial/military/religious scale.

It is a certainty that Satan was making a concerted attempt to gather the whole world to himself, and that the demonic interaction with human beings on the earth, whatever the nature of that activity truly might have been, was serious enough for God to bring the destructive Flood during the days of Noah. It would, in fact, not be surprising at all to someday learn that the pre-Flood world, especially the latter part, was indeed dominated by fallen angels, and that they had succeeded in utilizing every tool at their disposal to deceive, ensnare, and control the entire population of the earth.

It is very likely that, among human beings, the line of Cain figured most prominently in the web of deception and evil woven by Satan and his cohorts. Although this is merely a personal opinion, I have often wondered if the genealogy of Cain listed in Genesis 4 did not comprise some sort of antediluvian pantheon. In other words, these particular characters mentioned in Cain’s lineage so yielded themselves to the direct influence and empowerment of demons, that they became legendary in their own time, and perhaps

became the basis for the many gods and goddesses of the various post-Flood religious systems. It is of more than passing interest that there are precisely 12 names given in the line of Cain, especially when combined with the fact that most of the later pantheons contained 12 great deities. I rather doubt that this is a mere coincidence.

Although we may not be in possession of enough facts to be exact in our knowledge or complete in our understanding with respect to the pre-Flood world, suffice it to say that the desire on the part of Satan to take over this world by working through certain selected individuals and groups is almost certain to have been extant during that primordial time period.

It should be clear to us that God, while He is patient and will permit many evil events to be perpetrated by His enemies, does indeed draw a line at certain times. It is evident that He has dramatically intervened to literally change the course of human history on a number of signal occasions. The great Deluge may have been the first of such divine interference in the affairs of man, the objective being to limit the extent to which both demons and humans could progress in their evil schemes.

A second and very obvious example of this action transpired within a relatively short time after the Flood. It is a story with which we are all too familiar. A descendent of Ham, son of Noah, named Nimrod, the Scriptures state, became a mighty man upon the earth. Specifically, it is said:

“And Cush begat Nimrod: he began to be a mighty one in the earth. He was a mighty hunter before the Lord: wherefore it is said, Even as Nimrod the mighty hunter before the Lord. And the beginning of his kingdom was Babel and Erech, and Accad, and Calneh, in the land of Shinar. And out of that land he went forth also into Assyria, and built Nineveh, and the city Rehoboth, and Calah, and Resen between Nineveh and Calah: the same is a great city” (Gen. 10:8-12).

It is very interesting to note the striking parallel between Cain and Nimrod. Both became the mightiest men on the earth in their respective day and time, both were worshiped, both were evil and used by Satan as his chief instrument of wickedness, both were city-builders, the empires of both men were located in virtually the same area as well, and both men started something that caused God to dramatically intervene and alter human history.

In the case of Nimrod, we all know how that under his leadership the people determined to build a certain tower in the city of Babel or Babylon. The Bible states:

“And they said, Go to, let us build us a city and a tower, whose top may reach into heaven; and let us make us a name, lest we be scattered abroad upon the face of the whole earth” (Gen. 11:4).

Notice carefully that these people were not just building a city or a tower. There were cities and towers everywhere at that time and

later. No, there was more than perhaps meet the eye in this situation. A clue, however, is given to us in the statement: **“Let us make us a name.”** This indicates a state of heart that was evil to the core. These people, so cleverly duped and controlled by Satan through his agent Nimrod, were imbued with delusions of grandeur. They were infected with the same spiritual disease that Lucifer had when he presumed to think that he was greater than the Almighty Himself. And listen carefully just how God responded to this situation:

“And the Lord came down to see the city and the tower, which the children of men built. And the Lord said, Behold, the PEOPLE ARE ONE, and they have all one language; and this they begin to do: and now NOTHING will be restrained from them, which they have imagined to do” (Gen. 11:5-6).

God’s reply really says it all. It tells us precisely how He viewed the circumstances and the real danger that was involved in this incident. And just what was that danger—that the PEOPLE WERE ONE!! This is exactly what Nimrod and his followers were seeking to accomplish—uniting all peoples on the earth under his rulership (actually Satan’s, of course!). And God adamantly refused to permit this to happen. Why? Because to have allowed this sinister plan to continue on to fruition would have destroyed His own purposes for creating man in the first place. Something had to be done. The people had come under the sway of the devil to such an

extent that God simply had to powerfully put a stop to their activity, lest they forced Him to literally destroy them all.

Of course, we know what happened. God confounded their language, so that they could not communicate one with another, and scattered them upon the face of the earth. In other words, He personally and purposely wrecked the first post-Flood attempt at a one-world government!!

Ever since that signal episode at the infamous tower of Babel, Satan has been working through centuries of time and with specific individuals and groups in each generation of human kind, aimed at achieving his ultimate goal of wresting control of the creation from the hands of God the Father and His Son. At times, he has had some striking successes, but never enough to actually accomplish his goal. God has continued to intervene in the affairs of men just to the degree necessary to keep Satan at bay and, of course, work out His own plans at the same time.

That the desire and push for global domination has been and continues to be ongoing is without question or doubt. Satan needs to work with, in, and through human beings. Since his goal is total control of the world, the gathering together of all peoples, the amalgamation of all politics, diplomacy, science, technology, finance, military, and religion, he has presented himself as an angel of light to key people throughout history, recruiting them to work for him, convincing them that he is the true god, and that what they are

doing will be for the ultimate good of mankind. He has seen to it that these people and groups were successful in this world's goods. Money has flowed to the key individuals, families, bloodlines, and subsequent secret societies, deceived and used by Satan in the prosecution of this diabolical plan.

Although anciently there have been underground movements that could easily be considered a part of the devil's program, it is really during the last 350-400 years that things have begun to pick up steam, and this has been especially so over the last 150 years. Indeed, as the world has moved closer and closer to the time period in which we live today, the efforts by Satan and his cohorts to achieve his purposes have greatly intensified.

It does not take a degree in rocket science to discern the way that the devil is working. After all, we have nearly 6000 years of human history in which to view his handiwork. But few people have the interest or take the time to really understand how their enemy is working. There is an old Italian saying: *Keep your friends close, but your enemies closer*, and I would submit to you that there is a lot of truth and wisdom in those words.

We are admonished by the apostle Paul to make ourselves acutely aware of our enemy and his subtle devices. We are commanded to withstand the devil face-to-face, and this cannot and will never be done by a people who are self-satisfied, laid back, comfortable, and secure, confidently assuming that everything is okay!

While the roots of global domination undoubtedly go back to the very garden of Eden and Satan's original encounter with man, and the subsequent pre-Flood world of Cain and his descendants, it is from Nimrod in the antediluvian world that the Satanic Mystery System is derived.

The origins of what later became known as the *Illuminati* go back to Mesopotamia and to the Aryans—those fierce people who conquered the Indus Valley, who created the Brahmans, the Mitanni, the Hittites, the Hurrians, the Assyrians, the Babylonians, and the Persians. According to author Fritz Springmeier in his book, *Bloodlines of the Illuminati*, The Aryans gained a military superiority over other peoples by developing breeds of war horses and horse-drawn chariots with spoked wheels.

The ancient Aryans taught a theology of power. They espoused a religion that justified their enslavement of others and their blood sacrifice of lesser humans. The *Illuminati* creeds were developed centuries and centuries ago by power-hungry men who were enticed to believe that they were destined to rule over the rest of humanity. The *Illuminati* are elite bloodlines that are married to the practices of black magic and Satanism to gain power. As a male or female within these bloodlines goes through his or her religious training, they learn all kinds of theologies, myths, and gods. One common thread, however, that always permeates this training is the desire for power. They have a very ego-centric prideful theology that dehumanizes its believer. The

secret societies of the *Illuminati* practice occult theocracies that are totally removed from the teachings and examples of Jesus Christ, even though the leaders of many professing Christian groups operate within the *Illuminati's* sphere of influence. Because they have money, power, and what they believe is both history and god on their side, they create conflicts which squeeze and pressure those who are not of their bloodlines.

Over the thousands of years, the leadership of these secret power-hungry political/religious sects have held to a secret monotheism, even when they allowed polytheism to flourish among the common people. They have always worshiped a god of power and of evil. In fact, they are worshipers and followers of the one great evil genius who has the ability to masquerade as an angel of light—who is capable of conducting the ultimate Machiavellian deception—the ability to produce pure evil while appearing as a beautiful angel. And this principle has always been and continues to be the *modus operandi* of the power elite in this world—establishing governments, making laws, issuing decrees, establishing social policies, conquering nations, enslaving peoples, robbing others, and committing murder—and making it all seem as though it were for the good of the people involved.

The ancient mysteries secret taught their adherents Gnosticism, which has as one of its major tenets the principle that one's good deeds must balance one's bad deeds. It is based on what is commonly known as the yin-yang concept. When

these people are evil, they are what can be best termed as *Satanists*, but when they are good, they are hailed as heroes, saviors, and benefactors.

The Prince of Darkness and his followers have developed an intricate plan of attack against mankind. Many people, including believers, do not recognize that Satan actually has real plans, detailed plans, ingenious plans, and that they are designed for the long haul. The apostle John was so right when he said: **“The whole world lies in the control of the evil one” (I Jn. 5:19).**

More often than not, Christians and non-Christians alike are basically unaware of how Satan operates and especially how he controls his world. Some believe that he controls only through influencing the thoughts of people, but they are totally ignorant that Satan actively works on the physical level and has organized his empire extremely well. Because of the lack of understanding of how the devil has organized his realm and transmits orders, most people have been totally susceptible to all kinds of deceptions and misconceptions. Remember that Christ warned us that Satan's empire is not divided.

Satan is systematically destroying or seeking to destroy the earth through his wicked empire. It is vitally important for God's people to understand how this realm works and what it intends to do to them. The apostle Paul admonishes us in this regard by saying:

“Have no fellowship with the unfruitful works of darkness, but rather reprove them. For it is a

shame even to speak of those things which are of them in secret...Wherefore He says, Awake you that sleep, and arise from the dead, and Christ shall give you light. See then that you walk circumspectly, not as fools, but as wise, redeeming the time, because the days are evil. Wherefore be you not unwise, but understanding what the will of the Lord is” (Eph. 5:11-17).

To the church of God at Corinth, Paul wrote:

“I fear, lest by any means, as the serpent beguiled Even through his subtlety, so your minds should be corrupted from the simplicity that is in Messiah” (II Cor. 11:3).

Notice that Paul describes Satan's desire to *beguile* Eve. The word *beguile* means to seduce completely. He states that the devil accomplished this goal through his *subtlety*. What is *subtlety*? It means adroitness in a bad sense, cunning, craftiness, trickery or sophistry. Sophistry means unsound or misleading, yet very clever arguments or reasoning.

It is a proven fact of history that elite, evil groups of men organized themselves to protect and perpetuate their powerful bloodlines, as well as to shield their nefarious activities. This organization has often been called simply *The Brotherhood* or *The Brotherhood of the Snake*. The goal of the Brotherhood was and still is to unite the world by any means possible, and bring it under complete Satanic rule. The Brotherhood has been at work throughout history in its devotion to

accomplishing this objective.

An understanding of how Satanism works will help clarify how important bloodlines are. Occult (Satanic or demonic) power is transmitted from one generation to another. The leading Satanists believe that unless you have generations of occult power behind you, that you do not qualify for the higher positions within the order. Genealogies are, therefore, of the utmost importance.

The Brotherhood became dominant in many ancient societies, such as Egypt, Assyria, Babylon, Persia, Greece, and Rome. From these societies occult religions were encouraged, cultivated, and controlled by the Brotherhood. In time, a web of evil control has been spun around the world.

One of the methods by which Satan has entrapped those whom he uses is by the human intellect. First, a chosen man's natural conscience is destroyed by intellectual systems of thought (often devised by *Illuminati* think tanks and promulgated by *Illuminati* controlled schools, colleges, and universities), and then his own imagination is elevated (remember that God intervened at the tower of Babel because He knew that whatever the people imagined they would be able to do), and he is told by the higher powers that he can gain true enlightenment and divinity, but only by coming under the sway of those above him.

The Brotherhood was and still is an esoteric or secret order and religion, whose teachings are arranged in a step-by-step process.

After a student completes one level of instruction, he takes an oath of secrecy and silence to graduate to the next level. The highest levels of the Brotherhood are purely Satanic. The Mystery Schools of Egypt and Babylon are classic examples of the Brotherhood order, as is Freemasonry, especially at its highest echelons.

The leadership of the Mystery Schools has learned how to control the common people. They utilize the Babylonian system created by Nimrod which marries the power of the state to the power of religion. This locks the average person into control. Then the Brotherhood of Illuminati use the concept of divide and conquer to further insure their control over the masses. Many different competing religions, denominations, and sects are created. Numerous forms of political and governmental systems are established, thus fostering continual friction and conflict among all peoples.

The Brotherhood knows full well that knowledge is power, and it is they who claim to have the keys to secret hidden knowledge. Others must come to them to acquire this knowledge, which is then given to new members in increments.

To quote Fritz Springmeier once again:

“With so much secrecy surrounding the Brotherhood, it was hard for anyone to recognize its influence, and if someone did and tried to do something about it, they were blackmailed or killed. Satan does not hesitate to kill anyone who gets in his way.

Step by step, the Brotherhood became entrenched in our ancient societies, and many Brotherhood members had developed Satanic bloodlines. The members also took control of the world's monetary system, because the devil knows that the love of money is a root of all evil. He knows that he can ensnare good people with the earth's temporal wealth.”

So, we have wealth, intelligence, knowledge, wisdom, love, divinity, imagination, God—the very things that all humans go in search of, being used by those in power to trap and enslave humanity, even as the poor, hapless victims are actually being deceived into believing that their captors are their benefactors! It is surely the ultimate in diabolical schemes, attributable only to Satan himself.

Although this series of messages is really planned to cover primarily the activity of the Brotherhood in Britain and America, one should not assume that the powerful families in those nations alone comprise the modern-day *Illuminati*. There are members in many other countries as well.

One of the ways the various families keep control of their own bloodlines and hence their own future and fortune is through marriage, often complicated marriage, sometimes even incestuous. For instance, the book *Bloodlines of the Illuminati* reveals the following:

“These powerful oligarchical families are widespread. People familiar with Slavic countries will

recognize the Russian Stroganov family, and Hungarian Esterhazys and the Radziwills. The wife of Boris Yeltsin is the daughter of Joseph Stalin from Stalin's marriage to Roza Kaganovich, who also was Jewish. Roza's father was Illuminati...Boris Yeltsin and Roza are secretly Jewish. Yeltsin's original name was Baruch Ellia. It is interesting that the first Communist leader of the USSR, Nilolai Lenin was married to a Jewish woman. Molotov was as well. Stalin's wife Roza had a brother, Lazar Kaganovich, a powerful member of the Soviet Politburo, and whose son married Stalin's daughter Svetlana."

A number of the prominent families in the Corsican and Sicilian Mafia have been associated with certain factions of the Brotherhood. By no means does that indicate that the Mafia is indoctrinated into the order, but that it is structured along the same lines and patterns, and is used by the Brotherhood, especially in such areas as drug smuggling and selling. The Mafia provides an example of powerfully aligned crime families who, though not a direct part of the Brotherhood and not initiated into the actual worship of Satan, still are associated in business with the power elite. The Mafia families and their struggles, feuds, and rivalries along bloodlines is typical of the survival of the fittest principle at work within the Illuminati families as well. The strong and the ruthless make it.

What I want to do in this particular message is begin a study on the people and events which Satan has utilized or brought to pass over the last 150 years or so in his attempt to take over this world. Up until the present moment, God has simply not permitted the adversary to successfully accomplish his goal. The Bible confirms, however, that this will not always be the case. A time is predicted when, for a short season, Satan will be allowed to fulfil his wishes, and the objective which he has desired for so long will be temporarily achieved. That day is approaching, and it is not by accident that we are seeing and sensing more and more of Satan's hand in the affairs of this world.

Not only do I want to cover approximately the last 150 years, but specifically the part that certain Europeans and Americans have played during this critical period. When seeking to find the truth with respect to what is really happening behind the scenes, no matter what the level, you will almost always discover that things are not as they seem. The secret schemes of men in their lust for power and greed is fathered and fueled by the demonic world, since the players, despite their wealth, rank, and ability to control others, are, in reality, merely puppets on strings in the hands of Satan.

Those of us who are blessed to live in western Europe or America, as well as the various possessions of these nations, give precious little thought and consideration to what is going on right in our own countries. It seems that the good life has blinded us, and caused us to live lives based

firmly on mere assumptions. We mostly just want to be left alone to pursue our own happiness. Because we are so typically complacent, so easily distracted, so rarely focused, have so much in terms of leisure time, money, commodities, luxuries, it has been easy for those with evil plans to work their wickedness in the free and open societies that we all prize so highly and profit from so greatly. They have been able to successfully hide their real motives, work secretly to weave their own plans into the fabric of national life, exert influence and undue pressure upon elected government officials from the President or Prime Minister on down. They have, in fact, accomplished the almost unbelievable!! I am talking about controlling the government, the social order, the educational system, the religion, the military, the economic factors and flow of currency, the entertainment, and the business life of many nations in the world. It is an incredible story that reads stranger than fiction, and I suppose it stands, in a perverse manner of speaking, as a monument to the perfect wickedness of the devil and his henchmen.

The Satanic goal of one world is as old as the garden of Eden. It can be traced through the centuries and millennia of time. This is especially true from the era of the Holy Roman Empire on, and becomes more and more pronounced and intense as we come forward to our current world situation. Although it is outside the scope of this particular message, I will say that delving into the distant past on this subject is extremely interesting and informative. Some few of you might have already done

such a study, maybe others will decide to pursue the story more deeply. I won't take the time right now to go into the maze of secret societies, the European underground, the development of royal bloodlines, the involvement of Freemasonry, and things of this nature. All of them are important keys to understanding the whole picture, but we are going to focus primarily on the European/American conspiracy.

The first national bank ever established was the Bank of England, founded in 1694 by William Patterson. An institution of this nature is more customarily termed a *Central Bank*, and it is usually vested with extraordinary power over the monetary management of the country in question. The concept of central banks, begun in England over 300 years ago, set the pattern and the stage for the creation of numerous such private financial establishments throughout Europe and later in America as well. The reason I mention central banks is that they play such an integral and significant part in the plans of those who would subjugate the world under their rulership.

A central bank is usually a private organization, yet it is given the primary voice in controlling the economic conditions of the nation. So, in reality, public money is placed into private hands, and all done right under the noses of the unsuspecting citizenry. Most national or central banks were formed through highly secret negotiations among the rich and powerful. They were then foisted off on a duped public as something

necessary and beneficial. This, of course, is the very method that Satan has always used. Remember that the Messiah once stated that the king of the Gentiles exercise authority over their subject, and that they are considered to be benefactors by the people. This is the cunning approach the devil uses to worm his way into the life of nations and weave his philosophy into the minds of the common man.

Central banks have been responsible for some of the most disastrous events to plague the world over the last 150-200 years. The monetary control they have exerted has allowed them to completely regulate the economic circumstances of the countries in which they are established. They have been guilty of financing wars throughout the world, often backing both sides, and, of course, reaping the benefits, no matter what the outcome might turn out to be. When a nation is facing a crisis situation, why the central banks agree to step in and loan money to the state, but they never do it without an ulterior motive. They always insist on being given more and more control in exchange for the monetary bailouts they accomplish. In this way, the central banks of both Europe and America have obtained enormous powers over the years, and, in spite of ostensible government oversight, they have managed to easily finagle their way through the legal loopholes supposedly designed to prevent this sort of thing from happening.

For the next 100 years or so, powerful families in Europe, both of royal and common blood

(although much of it royal), began to merge into association with each other, imbued with a jointly shared purpose of doing whatever was necessary to control more and more of the world's people, resources, and wealth.

In 1776, a man by the name of Adam Weishaupt was a professor at the University of Ingelstadt in Germany. He was very well connected to the various powers that be, and in May of that year, was used by the powerful families of that time as a front man in the formation of what came to be known as the *Illuminati* or enlightened ones. While there were certainly precursors to the formation of this particular group, the popular usage of the word itself almost surely derived from the association established by Adam Weishaupt.

This secret organization consisted of the rich and powerful or their chosen representatives, and, to the extent that it was feasible, they determined to work toward, accomplish, and maintain control of the following goals:

1. Abolish land ownership
2. Create a tax on private income
3. Abolish the rights of inheritance
4. Confiscate property of rebels
5. Centralize credit - Nat. Banks
6. Control transportation & comm.
7. Equal liability of all to labor
8. Distribution of the population
9. Free public education, but under state control

As you can easily see, a number of these goals have already been achieved. Some of them are currently in the process of coming to pass. In some instances only

partial success has been gained. Certainly the income tax, confiscation of property belonging to those who oppose the ruling powers, centralization of credit and the creation of national or central banks, and control of public education, have all been implemented throughout much of the world, and especially in Britain and America.

Many people today have heard the term *illuminati*, but, what with all the conspiracy hype, just the mention of it sends some folks into a rage. The fact is, however, that this entity has provable historical background. It was real then, and it is still real to this day! There is absolutely no doubt that it existed. No less a personality than the leader of the American Revolution and first president of this country, George Washington, spoke the following warning to the people of his day:

“It was not my intention to doubt that the doctrines of the Illuminati...had not spread in the United States. On the contrary, no one is more fully satisfied of this fact that I am”

In 1797, the internationally renowned scientist and professor of Natural Philosophy at Edinburgh University, John Robison, published a book exposing the Illuminati. It was entitled *Proofs of a Conspiracy against all Religions and Governments of Europe, carried on in the Secret Meetings of the Freemasons, Illuminati, and Reading Societies*. With respect to the newly formed *Illuminati*, Dr. Robison declared:

“An Association has been formed for the express purpose of rooting out all the religious establishments, and overturning all the existing governments of Europe...Their leaders seek to rule the world with uncontrollable power, while the rest will be employed as mere tools of the ambition of their unknown superiors.”

At about the same time, another book, totally independent of and indeed more revealing than Robison's work, appeared in France. It was written by Abbe Barruel, and entitled *Memoirs of Jacobism*. Mon. Barruel wrote the following with respect to the Illuminati:

“It is formed for that general revolution which is to overthrow all thrones, all altars, annihilate all property, obliterate all law, and end by dissolving all society.”

John Adams, the second president of the United States, actually proclaimed a national day of fasting, because he felt that the fledgling American government was in danger of being infiltrated and taken over by agents of this very same group known as the *Illuminati*.

In a letter from Thomas Jefferson to John Adams, Jefferson stated his agreement with Adams that the international bankers were more powerful and dangerous than standing armies!

In 1812, the president of Harvard University, Joseph Willard, said the following with regard to the *Illuminati*:

“There is sufficient evidence that a number of societies of the Illuminati have been established in this land. They are doubtless striving to secretly undermine all our ancient institutions, civil and sacred. These societies are clearly leagued with those of the same order in Europe...We live in an alarming period. The Enemies of all order are seeking our ruin. Should infidelity generally prevail, our independence would fall, of course, Our republican government would be annihilated.”

Adam Weishaupt was funded entirely by the Satanic bloodlines of the Brotherhood. The purpose of the Illuminati was to recruit high ranking Freemasons into the Order. Freemasonry already reflected the agenda of the Brotherhood, but there needed to be a special circle of Illuminati representatives within the highest echelons of Freemasonry. In this way, the plans of Satan could be extended more easily and effectively. Here are Weishaupt's own words with respect to the purpose of the group:

“The true purpose of the Order is to rule the world. To achieve this it is necessary for the Order to destroy all religions, overthrow all governments, and abolish all private property.”

Initiates to the Order were sworn to secrecy, taking an oath that they will remain secret and silent on penalty of death. Weishaupt encouraged all members of the Illuminati to lie and deceive. He said:

“One must speak sometimes one way and sometimes another...so that, with respect to our true line of thinking, we may be impenetrable.”

Another means of deception was and is the use of symbols, arcane themes or motifs (found often in art and literature from the Middle Ages on), and pen names. Adam Weishaupt's code name was Spartacus.

The Illuminati has been able to successfully attract and recruit members by offering immense power, influence, wealth, and worldly success. The members are taken through the Brotherhood process by initiation, step-by-step, level-by-level. Originally there were 13 levels or degrees inside the Order. These were loosely based on the 13 tribes of Israel (the tribe of Joseph being split between Ephraim and Manassah), although the number 13 has numerous occult connections as well. A member of the highest degree was called a King, the second highest a Priest, the third a Prince, etc. Later the Illuminati reorganized and adapted a 6-level system with ranks at each level or degree.

The existence of the Illuminati, although indeed generally a secret society, has not gone completely unnoticed, as the previously quoted material from the first three American presidents and others clearly indicates. In more recent times, others have spoken out against the Brotherhood and its evil plans and power.

In the December 24th, 1912 edition of the *Vienna Free Press*,

Walter Rathenau wrote: **“Three hundred men, each of whom knows all the others, govern the fate of the European continent, and they elect their successors from their entourage.”**

Many years later in 1980, Dr. John Coleman wrote a book entitled *The Committee of 300*, in which he discussed very detailed material gathered by himself and other sources from the MI-6 branch of British Intelligence. In a treatise on this same issue, author David Hill states the following:

“The guiding force behind the Illuminati has always been certain demonic spirits assigned to steer the leaders of the society.”

In other words, the kingdom of Satan is structured or ordered from the top down. Under Satan are other demonic beings with varying degrees of enlightenment and power. When the book of Daniel speaks of the prince of Persia and the prince of Greece, it is with obvious reference to such evil angelic beings who have been given control over various parts of the earth and specific human leaders and groups that are a part of the overall hierarchy and system of evil.

Fritz Springmeier states that:

“The human command structure of the Illuminati is difficult to understand since it is concealed from the general population. The levels can be defined as interlocking organizations and societies that vary in their operation and status...A person can be involved in a high level

organization, and at the same time function in lower groups. For example, a high school student body president has a high position, but can also be a member of the school Science Club, a far less influential or important group.”

Traditionally, the members at the top, those descended from the ancient privileged and empowered bloodlines, called themselves Kings. Today, they are known as the Olympians (clearly a throwback to the ancient, impregnable, unapproachable, lofty abode of the gods). There are 13 major Illuminati bloodlines, but these powerful families are associated, either closely or loosely, with numerous other enlightened, strong, well-entrenched bloodlines, groups, and individuals.

The 13 Illuminati bloodlines come primarily from Europe, America, and perhaps, in one instance, from China. The associated families can be found in Russia, the Middle East, Europe, and the United States. The top 13 bloodlines, through their representatives (either appointed or elected) put pressure on and control to one degree or another the activities of the associated families, even though those groups are themselves exceedingly wealthy and powerful in their own right.

The Illuminati structure could be said to be divided into three spheres of responsibility, activity, and control. If we were to compare it to the American Federal government, the executive branch consists of the 13 major bloodlines, often referred to as the Council of

13. Under their leadership is the Committee of 300, comparable to the legislative branch of the American Federal government. Each member of this Committee not only has organizations that answer to him personally, but also the Committee itself jointly operates a number of other key organizations and secret societies. Finally, if we can continue our original analogy, the judicial branch consists of 70 members (perhaps loosely based upon the Jewish Sanhedrin).

Within the Illuminati or Brotherhood are many sub-committees and groups. Some of them are familiar to most people today, others are not. Such entities as the Bilderburgers, founded in 1954 by Prince Bernhard, the Club of Rome, originated by Dr. Angelo Paccelli, the Trilateral Commission, the Royal Institute for International Affairs, the Council on Foreign Relations, the Tavistock Institute, the Pilgrim Society, the Jason Society, the Golden Dawn, numerous secret high-level 33rd degree Masonic orders, the Bohemian Grove, the Order of Skulls and Bones, the Knights of Malta, the Scroll & Key, the Priory of Sion, the Tiffany Lamp Group, the Round Table, and so many others far too numerous to mention in this message.

Organized evil's greatest advantages are its ability to conceal its true identity by either total secrecy or by presenting itself as the benefactor of mankind, its genealogical connections, its wealth and thus its power to influence, and most especially the public's disbelief that something of this grotesque nature could actually

have been created and perpetuated even to this very day. Just as a reminder, recall how long it took for the US government, and the FBI in particular, to finally realize and admit that there were organized crime families operating in all the major cities of this country, and had been doing so for years to the tune of untold billions of dollars!

Although I hope to continue on in this subject, making perhaps a separate series of tapes, I am about out of time. Let me leave you with an amazing quotation from the one individual whom many would believe to be the *Man of the Century*, Sir Winston Churchill. Believe it or not, he too was quite familiar with the Illuminati, their history, and their current work. Notice his comments:

“From the days of Spartacus-Weishaupt to those of Karl Marx (and Lenin, Stalin, Hitler, e t c .) . . . t h i s w o r l d w i d e CONSPIRACY for the overthrow of civilization and for the reconstruction of society on the basis of arrested development, of envious malevolence, and impossible equality, has been steadily growing.”

Note that Prime Minister Churchill mentioned Marx and others, in addition to Adam Weishaupt. He did this because he was privy to the truth about who was really behind such men as Karl Marx and Frederick Ingels, creators of the *Communist Manifesto*, Nilolai Lenin, leader of the Russian Revolution, Joseph Stalin, and Adolph Hitler, founder of the German Nazi Party and ostensible instigator of WWII. He knew it was

the secret alliance of the powerful Illuminati bloodlines, international bankers (almost all of them on Wall Street in New York City), and other key personnel in powerful positions throughout the world. In fact, Churchill went on to say on another occasion, that the world is not what it seems to be, that it is actually ruled by unseen forces that are not even viewed as part of the power structure.

This information, brethren, is not intended to frighten anyone or cause despair. On the contrary, being an informed believer, understanding the methods and devices of our avowed enemy, and perceiving how and why things are developing all around us as they are, constitute part of the powerful arsenal of weapons all awake and active believers ought to possess.

Our hope is clear, and it is unquestionably that Almighty God wins the war and Satan the devil is utterly defeated. We should be walking in victory even at this very moment, though the circumstances surrounding us are shocking and chilling, and bound to be worse before the mend. The apostle Paul gives encouraging advice by saying:

“We are hard pressed on every side, yet not crushed; we are perplexed, but not in despair, persecuted, but not forsaken; struck down, but not destroyed.”

The so-called Illuminati is for real, and is almost certain to be used by Satan to usher in the final phase of this present age. But we will fear no evil—For He who is in us is greater than he who is in the world!
